Subject- Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) - on account payment of 1<sup>st</sup> Installment of 1<sup>st</sup>tranche of Central Assistance during the financial year 2022-23 to the State Government of Kerala.

Sir/Madam,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs.583,42,07,000/- (Rupees Five Hundred Eighty Three Crore Forty Two Lakh and Seven Thousand only) (Rs.51035.70 lakh towards Material Component + Rs.7306.37 lakhs for Admin Contingency) to the State Government of Kerala for implementation of Mahatma Gandhi NREGA for FY 2022-23. This Sanction amount includes Rs.28563.21 lakh for Material & Admin pending liabilities of previous FY 2021-22.

2. The State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under;

- 3. The pending liabilities of Rs.28563.21 lakh towards Material & Admin Component of previous FY 2021-22 should be cleared first and should be incorporated in the audited Utilization Certificate and Audit Report for the FY 2021-22. State may ensure timely releasing of state matching share against amount released by this Ministry towards Material.
- 4. Accounting of Admin Contingency should be maintained separately for assessing the matching State share towards material component from the angle of central release and to maintain the limit of 6% for expenditure on Admin Contingency.
- 5. Refund of the interest receipts to be Consolidated Fund of India in terms of Rule 230(8) of GFR, 2017.
- 6. Further the following conditions shall be fulfilled in utilisation of these funds:
  - Adherence to the time line indicated in the Minutes of the LB meeting for FY 2020-21 against various key activities.
  - b. In all Electronic Fund Management System (eFMS) 'implemented' areas, the funds shall be maintained at the State level; and there shall be no intermediary accounts. All payments in these areas shall move directly from the State fund to the destination accounts based on the pay order generated at the Block/Gram Panchayat level.
  - c. Where eFMS is not yet implemented, steps shall be taken to implement the same at the earliest.
  - d. The detailed voucher-based data shall be available in the NREGASoft for all the expenditure done.
  - e. The Material Component including wages of skilled and semi-skilled labour shall not exceed 40% at district level.
  - f. The Expenditure of Material Component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25.

This grant is towards plan expenditure and shall be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGAGuidelines. No deviation from the provisions of the Guidelines is permissible.

The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of financial year which shall include interest accrued. Interest accrued should be computed based on the details of ledger account maintained for the purpose.

- No Utilization Certificate is pending against the Recipient Organization under the Scheme. 7.
- Funds towards Admin Contingency must be used against Admin expenses (Salary etc.). 8.
- The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of 236 (1) of the General Financial Rules, 2017.
