I am directed to convey the sanction of the President of India for release of an amount of **Rs.2,64,92,336/- (Rupees Two Crore Sixty Four Lakh Ninety Two Thousand Three Hundred and Thirty Six Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Chhattisgarh as 138th Instalment out of the sanctioned amount of **Rs.1411,79,84,000/- (Rupees One Thousand Four Hundred Eleven Crore Seventy Nine Lakh and Eighty Four Thousand Only)** [(SC: **Rs.154,33,41,000/-**), (ST: **Rs.523,20,73,000/-**) and (Others: **Rs.734,25,70,000/-**)] vide Mother sanction order No. G-31011/10/2024 RE-V SI. No. - 111 dated 29.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs.19,57,88,255/-** [(SC: **Rs.3,89,02,702/-**), (ST: **Rs.15,68,78,737/-**) and (Others: **Rs.6,816/-**)] vide mother sanction order of even no. dated 18.07.2024 (U.O. No. **240/Finance/2024-25 dated 12.07.2024**) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.1411,79,84,000/- (NeFMS amount) + Rs.19,57,88,255/- (residual amount) of previous mother sanction i.e. total Rs.1431,37,72,255/-**.

8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
