2. The residual amount of Rs.19,57,88,255/- [(SC: Rs.3,89,02,702/-), (ST: Rs.15,68,78,737/-) and (Others: Rs.6,816/-)] vide mother sanction order of even no. dated 18.07.2024 (U.O. No. **240/Finance/2024-25 dated 12.07.2024**) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.1411,79,84,000/- (NeFMS amount)** + **Rs.19,57,88,255/- (residual amount) of previous mother sanction i.e. total Rs.1431,37,72,255/-**.

3. The total amount available for release to the State for wages Rs.632,81,,72,612/- is as under:-
