2. The residual amount of Rs.19;57,88,255/- [(SC: Rs.3,89,02,702/-), (ST: Rs.15,68,78,737/-) and (Others: Rs.6,816/-)] vide mother sanction order of even no. dated 18.07.2024 (U.O. No. 240/Finance/2024-25 dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds.
