2. The residual amount of Rs.19,57,88,255/- [(SC: Rs.3,89,02,702/-), (ST: Rs.15,68,78,737/-) and (Others: Rs.6,816/-)] vide mother sanction order of even no. dated 18.07.2024 (U.O. No. 240/Finance/2024-25 dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.1411,79,84,000/- (NeFMS amount) + Rs.19,57,88,255/- (residual amount) of previous mother sanction i.e. total Rs.1431,37,72,255/-.
