Subject: **Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 4th Installment of 1st tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Chhattisgarh.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.8,83,157/- (Rupees Eight Lakh Eighty Three Thousand One Hundred and Fifty Seven Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Chhattisgarh as 7th Instalment out of the sanctioned amount of **Rs.31,58,16,429/- (Rupees Thirty One Crore Fifty Eight Lakh Sixteen Thousand Four Hundred and Twenty Nine Only)** [(SC: **Rs.2,46,06,070/-**), (ST: **Rs.9,90,16,797/-**) and (Others: **Rs.19,21,93,562/-**)] vide Mother sanction order No. G-31011/10/2024 RE-V SI. No. – 60 dated 18.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs.20,63,48,129/-** [(SC: **Rs.5,07,28,607/-**), (ST: **Rs.15,56,02,768/-**) and (Others: **Rs.16,754/-**)] vide mother sanction order of even no. dated 07.06.2024 (U.O. No. **143 /Finance/2024-25 dated 07.06.2024**) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.31,58,16,429/- (NeFMS amount) + Rs.20,63,48,129/- (residual amount) of previous mother sanction i.e. total Rs.52,21,64,558/-**.

3. The total amount available for release to the State for wages **Rs.19,81,90,943/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
5. Further instalment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in Mother Sanction order **G-31011/10/2024 RE-V Sl. No. - 60** dated 18.07.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017**.
10. The DDO Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No. 36110181246** in the name of Commissioner, Mahatma Gandhi R.G.R.G.Y SEGF NeFMS, in the State Bank of India, Branch KutcheryBalashram Complex Jail Road, Raipur, **Branch IFS Code No. SBIN0003314 and MICR Code No. 492002007**.
11. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O Number 240/Finance/2024-25 dated 12.07.2024**.
