No.-1 16 dated 10.09.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The residual amount of Rs.82,44,79,288/- [(SC: Rs.70,12,50,886/-), (ST: Rs.10,37,35,366/-) and (Others: Rs.1,94,93,036/-)] vide mother sanction order of even no. dated 12.08.2024 (U.O. No. 355/Finance/2024-25 dated 12.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. - 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
- 9. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No. 61310273176 in the State Bank of India, Branch R Block, Patna, Branch Code No. 10501 and Branch IFSC SBIN0031501.
