No.-116 dated 10.09.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The residual amount of Rs.82,44,79,288/- [(SC: Rs.70,12,50,886/-), (ST: Rs.10,37,35,366/-) and (Others: Rs.1,94,93,036/-)] vide mother sanction order of even no. dated 12.08.2024 (U.O. No. 355/Finance/2024-25 dated 12.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds.
