No.-116 dated 10.09,2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The residual amount of Rs.82,44,79,288/- [(SC: Rs.70,12,50,886/-), (ST: Rs.10,37,35,366/-) and (Others: Rs.1,94,93,036/-)] vide mother sanction order of even no. dated 12.08.2024 (U.O. No. 355/Finance/2024-25 dated 12.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.770,14,71,500/- (NeFMS amount) + Rs.82,44,79,288/- (residual amount of previous mother sanction) i.e. total Rs.852,59,50,788/-.
