I am directed to convey the sanction of the President of India for release of an amount of Rs.11,78,84,072/-(Rupees Eleven Crore Seventy Eight Lakh Eighty Four Thousand and Seventy Two Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Bihar as 76<sup>th</sup> Instalment out of the sanctioned amount of Rs.770,14,71,500/- (Rupees Seven Hundred Seventy Crore Fourteen Lakh Seventy One Thousand and Five Hundred Only) [(SC: Rs.163,45,18,000/-), (ST: Rs.17,26,36,000/-) and (Others: Rs.589,43,17,500/-)] vide Mother sanction order No. G-31011/11/2024 RE-V SI. No.-116 dated 10.09.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The residual amount of Rs.82,44,79,288/- [(SC: Rs.70,12,50,886/-), (ST: Rs.10,37,35,366/-) and (Others: Rs.1,94,93,036/-)] vide mother sanction order of even no. dated 12.08.2024 (U.O. No. **355/Finance/2024-25** dated **12.08.2024**) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.770,14,71,500/-** (NeFMS amount) + **Rs.82,44,79,288/-** (residual amount of previous mother sanction) i.e. total **Rs.852,59,50,788/-**.
