Subject: **Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 3<sup>rd</sup> Instalment of 2<sup>nd</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Bihar.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.4,95,18,474/- (Rupees Four Crore Ninety Five Lakh Eighteen Thousand Four Hundred and Seventy Four Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Bihar as 3<sup>rd</sup> Instalment out of the sanctioned amount of **Rs.589,43,17,500/- (Rupees Five Hundred Eighty Nine Crore Forty Three Lakh Seventeen Thousand and Five Hundred Only) [(SC: Rs.0/-), (ST: Rs.0/-) and (Others: Rs.589,43,17,500/-)]** vide Mother sanction order No. G-31011/11/2024 RE-V Sl. No.-139 dated 12.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The residual amount of Rs.103,50,80,187/- [(SC: Rs.90,08,02,354/-), (ST: Rs.12,24,81,911/-) and (Others: Rs.1,17,95,922/-)] vide mother sanction order of even no. dated 10.09.2024 (U.O. No. 470/Finance/2024-25 dated 10.09.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.589,43,17,500/- (NeFMS amount) + Rs.103,50,80,187/- (residual amount of previous mother sanction) i.e. total Rs.692,93,97,687/-.**

2. The total amount available for release to the State for wages **Rs.678,25,80,137/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
4. Further instalment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in Mother Sanction order G-31011/11/2024 RE-V SI. No. – 139 dated 12.11.2024 shall remain the same.
7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
9. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No. 61310273176 in the State Bank of India, Branch R Block, Patna, Branch Code No. 10501 and Branch IFSC SBIN0031501.
10. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O Number 690/Finance/2024-25 dated 11.11.2024.
