Subject: Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 3rd Instalment of 1st tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Bihar.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.32,71,78,967/- (Rupees Thirty Two Crore Seventy One Lakh Seventy Eight Thousand Nine Hundred and Sixty Seven Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Bihar as 9th **Rs.347,08,34,000/- (Rupees Three Hundred and Forty Seven Crore Eight Lakh Thirty Four Thousand Only)** [(SC: **Rs.64,90,79,000/-**), (ST: **Rs.6,84,16,000/-**) and (Others: **Rs.275,33,39,000/-**)] vide Mother sanction order No. G-31011/11/2024 RE-V Sl. No. - 44 dated 14.06.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

PAO has reported Rs.5,16,14,796/- as refunded amount due to the failed transactions during May, 2024. This amount has also been included in the current mother sanction order under others category for utilizing the fund. The residual amount of Rs.124,59,99,074/- [(SC: Rs.1,69,53,873/-), (ST: Rs.2,10,82,698/-) and (Others: Rs.120,79,62,503/-)] vide mother sanction order of even no. dated 05.06.2024 (U.O. No. **140 /Finance/2024-25 dated 05.06.2024**) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.347,08,34,000/- (NeFMS amount) + Rs.124,59,99,074/- (residual amount of previous mother sanction)+ Rs.5,16,14,796/- (Re-initiated Amount) i.e. total Rs.476,84,47,870/-**.

2. The total amount available for release to the State for wages Rs.255,74,44,778/- is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
4. Further instalment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in Mother Sanction order G-31011/11/2024 RE-V Sl. No. — 44 dated 14.06.2024 shall remain the same.
7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017.**
9. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No. 61310273176** in the State Bank of India, Branch R Block, Patna, **Branch Code No. 10501 and Branch IFSC SBIN0031501.**
10. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O Number 156/Finance/2024-25 dated 14.06.2024.**
