I am directed to convey the sanction of the President of India for release of an amount Rs.76,83,482/- (Rupees Seventy Six Lakh Eighty Three Thousand Four Hundred and Eighty Two Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Arunachal Pradesh as 45<sup>th</sup> Instalment out of the sanctioned amount of Rs.82,42,32,000/- (Rupees Eighty Two Crore Forty Two Lakh Thirty Two Thousand Only) [(SC: Rs.1,65,000/-), (ST: Rs.77,24,13,000/-) and (Others: Rs.5,16,54,000/-)] vide Mother sanction order No. 31011/13/2024 RE-V SI. No.-107– Dated -27.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of Rs.2,70,18,692/- [(SC: Rs.5,712/-), (ST: Rs.2,10,729/-) and (Others: Rs. 2,68,02,251/-)] vide mother sanction order of even no. dated 20.08.2024 (U.O. No. 237/Finance/2024-25 dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.82,42,32,000/- (NeFMS amount) + Rs.2,70,18,692/- (residual amount of previous mother sanction) i.e. total Rs.85,12,50,692/-.
