No.-156 Dated-10.12.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs.1,83,90,149/- as refunded amount due to the failed transactions during June and Oct, 2024. This amount has also been included in the current mother sanction order under others category for utilizing the fund. Hence, the total amount available for release to the State for wages is Rs.105,82,55,500/- (NeFMS amount) + Rs.9,47,03,772/- (residual amount of previous mother sanction) + Rs.1,83,90,149/- (Re-initiation Amount)i.e. total Rs.117,13,49,421/-.

The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.50100347948413 in the name of NREGA SEGF-Ne-FMS Wage Account, in the HDFC, Branch Itanagar, Arunachal Pradesh, Branch IFS Code No. HDFC0001643.
