No.-57- Dated -20.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs.1,82,11,464/- as refunded amount due to the failed transactions during April and May, 2024. This amount has also been included in the current mother sanction order under others category for utilizing the fund.
