I am directed to convey the sanction of the President of India for release of an amount Rs.27,16,600/- (Rupees Twenty Seven Lakh Sixteen Thousand Six Hundred Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Arunachal Pradesh as 4th Instalment out of the sanctioned amount of Rs.3,32,21,776/- (Rupees Three Crore Thirty Two Lakh Twenty One Thousand Seven Hundred and Seventy Six Only) [(SC: Rs.3,136/-), (ST: Rs.2,85,33,680/-) and (Others: Rs.46,84,960/-)] vide Mother sanction order No. 31011/13/2024 RE-V Sl. No.-57- Dated -20.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

PAO has reported Rs.1,82,11,464/- as refunded amount due to the failed transactions during April and May, 2024. This amount has also been included in the current mother sanction order under others category for utilizing the fund. The residual amount of Rs.43,07,968/- [(SC: Rs.2,576/-), (ST: Rs.37,627/-) and (Others: Rs.42,67,765/-)] vide mother sanction order of even no. dated 06.04.2024 (U.O. No. 04/Finance/2024-25 dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.3,32,21,776/- (NeFMS amount) + Rs.43,07,968/- (residual amount of previous mother sanction)+ Rs.1,82,11,464/- (Re-initiated Amount) i.e. total Rs.5,57,41,208/-.

- 8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
- 10. The DDO Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.50100347948413 in the name of NREGA SEGF-Ne-FMS Wage Account, in the HDFC, Branch Itanagar, Arunachal Pradesh, Branch IFS Code No. HDFC0001643.
