- 2. PAO has reported Rs.10,51,09,179/- as refunded amount due to the failed transactions during June to Oct, 2024. This amount has also been included in the current mother sanction order under SC category and ST category for utilizing the fund. The residual amount of Rs.64,54,54,935/- [(SC:Rs.1,54,99,236/-), (ST: Rs.6,12,97,706/-and (Others: Rs.56,86,57,993/-)] vide mother sanction order of even no. dated 11.11.2024 (U.O. No. 686/Finance/2024-25 dated 8.11.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.3,00,000/- (NeFMS amount) + Rs.64,54,54,935/- (residual amount of previous mother sanction)+ Rs.10,51,09,179/-(Re-initiated Amount) i.e. total Rs.75,08,64,114/-.
