- 2. PAO has reported Rs.10,51,09,179/- as refunded amount due to the failed transactions during June to Oct, 2024. Hence, the total amount available for release to the State for wages is Rs.3,00,000/- (NeFMS amount) + Rs.64,54,54,935/- (residual amount of previous mother sanction)+ Rs.10,51,09,179/-(Re-initiated Amount) i.e. total Rs.75,08,64,114/-.
