I am directed to convey the sanction of the President of India for release of an amount Rs.38,22,668/- (Rupees Thirty Eight Lakh Twenty Two Thousand Six Hundred and Sixty Eight Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Maharashtra as 7<sup>th</sup> Instalment out of the sanctioned amount of Rs.3,00,000/- (Rupees Three Lakh Only) [(SC: Rs.1,00,000/-), (ST: Rs.1,00,000/-) and (Others: Rs.1,00,000/-)] vide Mother sanction order No. G-31011/8/2024 RE-V Sl. No. 137 dated 19.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- 2. PAO has reported Rs.10,51,09,179/- as refunded amount due to the failed transactions during June to Oct, 2024. This amount has also been included in the current mother sanction order under SC category and ST category for utilizing the fund. The residual amount of Rs.64,54,54,935/- [(SC:Rs.1,54,99,236/-), (ST: Rs.6,12,97,706/-and (Others: Rs.56,86,57,993/-)] vide mother sanction order of even no. dated 11.11.2024 (U.O. No. 686/Finance/2024-25 dated 8.11.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.3,00,000/- (NeFMS amount) + Rs.64,54,54,935/- (residual amount of previous mother sanction)+ Rs.10,51,09,179/-(Re-initiated Amount) i.e. total Rs.75,08,64,114/-.

- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
