I am directed to convey the sanction of the President of India for release of an amount Rs.15,56,83,221/- (Rupees Fifteen Crore Fifty Six Lakh Eighty Three Thousand Two Hundred and Twenty One Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Maharashtra as 2nd Instalment out of the sanctioned amount of Rs.501,17,26,500/- (Rupees Five Hundred and One Crore Seventeen Lakh Twenty Six Thousand Five Hundred Only) [(SC: Rs.35,44,69,500/-), (ST: Rs.88,20,90,000/-) and (Others: Rs.377,51,67,000/-)] vide Mother sanction order No. G-31011/8/2024 RE-V Sl. No. 36 dated 16.05.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs.9,93,01,800/- as refunded amount due to the failed transactions during April, 2024. This amount has also been included in the current mother sanction order under others category for utilizing the fund. The residual amount of Rs.28,11,58,939/- [(SC: Rs.8,35,05,396/-), (ST: Rs.18,09,86,045/-) and (Others: Rs.1,66,67,498/-)]vide mother sanction order of even no. dated 15.04.2024 (U.O. No. 31/Finance/2024-25 dated 15.4.2024.) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs.501,17,26,500/- (NeFMS amount) + Rs.28,11,58,939/- (residual amount of previous mother sanction) + Rs.9,93,01,800/- (Re-initiated Amount) i.e. total Rs.539,21,87,239/- .
