Sir/ Madam.

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs.49,41,750/- (Rupees Forty Nine Lakh Forty One Thousand and Seven Hundred and Fifty Only) as 1st installment of 2<sup>nd</sup> tranche of Financial Year 2021-22 of commencement of CFP to the State of Uttarakhand as Central assistance towards Cluster Facilitation Project [CFP] for the financial year 2024-25.

The State Government must transfer these funds to the CFP Bank account within 15 days of receipt of these funds. In case of non-transfer beyond this period, the State Government would be liable to pay interest @ 12% per annum for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under:

- The Sanctioned amount will be utilized for activities mentioned in the CFP Guidelines- December, 2019. No deviations from the provisions of the guidelines are permissible.
- The accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry.
- The release of the fund is subject to condition that in case of implementation of CFP at the Block level by CSO, the fund shall be released to those CSO's who have been signed up on the NGO-DARPAN Portal as mentioned in NITI Aayog OM No. M- 11/16 (2)/2015-VAC dated 28.10.2016.
- 6. should maintain a single nodal account as Department of Expenditure No.1(13)PFMS/FCD/2020, dated 23.03.2021 and as per Mahatma Gandhi NREGA Operational Guidelines, clause-12.3 for ensuring transparency and accountability in management of funds.
- 7. Further the following conditions shall be fulfilled in utilisation of these funds:
  - h) Adherence to the time line indicated in the Minutes of the LB meeting for FY 2024-25 against various key
  - In all Electronic Fund Management System (eFMS) 'implemented' areas, the funds shall be maintained at the State level; and there shall be no intermediary accounts. All payments in these areas shall move directly from the State fund to the destination accounts based on the pay order generated at the Block/Gram Panchayat level.
  - Where eFMS is not yet implemented, steps shall be taken to implement the same at the earliest.
  - The detailed voucher-based data shall be available in the NREGA Soft for all the expenditure done.
  - This grant is towards plan expenditure and shall be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines. No deviation from the provisions of the Guidelines is permissible.

- m) The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of financial year which shall include interest accrued. Interest accrued should be computed based on the details of ledger account maintained for the purpose.
- State should immediately refund interest receipt in consolidated fund of India in terms of Rule 230(8) of the GFR, 2017.
- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of 236 (1) of the General Financial Rules, 2017.
