I am directed to convey the sanction of the President of India for release of an amount of **Rs. 26,92,82,823/- (Rupees Twenty Six Crore Ninety Two Lakh Eighty Two Thousand Eight Hundred and Twenty Three Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Tamil Nadu as 3rd Installment of 1st tranche out of the sanctioned amount of **Rs.1594,99,99,000/- (Rupees One Thousand Five Hundred and Ninety Four Crore Ninety Nine Lakh Ninety Nine Thousand Only)** vide Mother sanction order No. J-11060/14/2024-RE-VI / Sl. No.109 dated 28/08/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

6. All other terms and conditions mentioned in Mother Sanction order J-11060/14/2024-RE-VI, Sl. No.109 dated 28/08/2024 shall remain the same.


7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017.**

9. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No. **6466789818** in the name of SEGS-NeFMS, Indian Bank, Saidapet, Chennai-15, Tamil Nadu, Branch IFS Code No. **IDIB000S004.**
