I am directed to convey the sanction of the President of India for release of an amount of **Rs. 17,02,73,812/- (Rupees Seventeen Crore Two Lakh Seventy Three Thousand Eight Hundred and Twelve Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Tamil Nadu as 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche out of the sanctioned amount of **Rs. 1,01,83,721/- (Rupees One Crore One Lakh Eighty Three Thousand Seven Hundred and Twenty One Only)** vide Mother sanction order No. J-11060/14/2024-RE-VI / Sl. No.80 dated 13/08/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

6. All other terms and conditions mentioned in Mother Sanction order J-11060/14/2024-RE-VI, Sl. No.80 dated 13/08/2024 shall remain the same.


7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
