No.54 dated 12.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 4,02,12,062/-** as refunded amount due to the failed transaction from 1<sup>st</sup> April, 2024 to 31<sup>st</sup> May, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs. 6,20,09,292/-**vide mother sanction order of even no. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.61328990252 in the name of SEGF-NeFMS-Himachal Pradesh, in the State Bank of India, Parvati Complex, Panthaghati, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763.
