
2. The residual amount of **Rs. 5,77,66,061/-** vide mother sanction order of even no. Dated 24.07.2024 (U.O.No.286/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 73,75,02,993/- (NeFMS amount) +Rs. 5,77,66,061/- (Residual amount of previous Mother Sanction) i.e. Rs. 79,52,69,054/-**
