No.123 dated 25.09.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.



Hence the total amount available for release to the State for wages is **Rs. 119,19,36,947/-** (NeFMS amount)+**Rs. 11,00,01,476/-**(Residual amount of previous Mother Sanction) i.e. **Rs. 130,19,38,423/-**

The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.61328990252** in the name of **SEGF-NeFMS-Himachal Pradesh**, in the **State Bank of India, Parvati Complex, Panthaghati, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763**.
