I am directed to convey the sanction of the President of India for release of an amount of **Rs. 2,41,17,026/- (Rupees Two Crore Forty One Lakh Seventeen Thousand and Twenty Six Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Himachal Pradesh as 6th installment out of the sanctioned amount of **Rs. 73,75,02,993/- (Rupees Seventy Three Crore Seventy Five Lakh Two Thousand Nine Hundred and Ninety Three Only)** vide Mother sanction order No. J-11060/19/2024-RE-III Sl. No.112 dated 29.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 11,00,01,476/-** vide mother sanction order of even no. Dated 29.08.2024 (U.O.No.401/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 119,19,36,947/- (NeFMS amount)+Rs. 11,00,01,476/- (Residual amount of previous Mother Sanction) i.e. Rs. 130,19,38,423/-**

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in sanction order F. No. J-11060/19/2024-RE-III SI.No.123 dated 25.09.2024 shall remain the same.
8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No.61328990252 in the name of SEGF-NeFMS-Himachal Pradesh, in the State Bank of India, Parvati Complex, Panthaghathi, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763.
