Subject:- **Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 2<sup>nd</sup> Installment of 2<sup>nd</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State of Himachal Pradesh.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 2,31,50,545/- (Rupees Two Crore Thirty One Lakh Fifty Thousand Five Hundred and Forty Five Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Himachal Pradesh as 14<sup>th</sup> installment out of the sanctioned amount of **Rs. 119,19,36,949/- (Rupees One Hundred Nineteen Crore Nineteen Lakh Thirty Six Thousand Nine Hundred and Forty Nine Only)** vide Mother sanction order No. **J-11060/19/2024-RE-III SI. No.138** dated 12.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 38,75,66,455/-** vide mother sanction order of even no. Dated 25.09.2024 (U.O.No.518/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 119,19,36,949/- (NeFMS amount)+Rs. 38,75,66,455/- (Residual amount of previous Mother Sanction) i.e. Rs. 157,95,03,404/-**

3. The total amount available for release to the State for wages is **Rs. 133,05,57,339/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.




