Subject:- **Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 2nd Installment of 2nd tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State of Himachal Pradesh.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 3,35,49,784/- (Rupees Three Crore Thirty Five Lakh Forty Nine Thousand Seven Hundred and Eighty Four Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Himachal Pradesh as 28th installment out of the sanctioned amount of **Rs. 119,19,36,949/- (Rupees One Hundred Nineteen Crore Nineteen Lakh Thirty Six Thousand Nine Hundred and Forty Nine Only)** vide Mother sanction order No. J-11060/19/2024-RE-III Sl. No.138 dated 12.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 38,75,66,455/-** vide mother sanction order of even no. Dated 25.09.2024 (U.O.No.518/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 119,19,36,949/- (NeFMS amount)+Rs. 38,75,66,455/- (Residual amount of previous Mother Sanction) i.e. Rs. 157,95,03,404/-**

3. The total amount available for release to the State for wages is **Rs. 100,99,37,509/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

7. All other terms and conditions mentioned in sanction order F. No. J-11060/19/2024-RE-III SI.No.138 dated 12.11.2024 shall remain the same.

8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.

9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.61328990252** in the name of **SEGF-NeFMS-Himachal Pradesh**, in the **State Bank of India, Parvati Complex, Panthaghati, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763**.
