7. All other terms and conditions mentioned in sanction order F. No. J-11060/19/2024-RE-III SI.No.8 dated 06.04.2024 shall remain the same.

8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.

9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No.61328990252 in the name of SEGF-NeFMS-Himachal Pradesh, in the State Bank of India, Parvati Complex, Panthaghathi, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763.
