5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in sanction order F. No. **J-11060/19/2024-RE-III SI.No.8** dated 06.04.2024 shall remain the same.
8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.61328990252** in the name of **SEGF-NefMS-Himachal Pradesh**, in the **State Bank of India, Parvati Complex, Panthaghati, Near Tenzin Hospital Shimla-171009, IFSC-SBIN0021763**.
10. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
 - i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any form whatsoever.
 - ii. No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
 - iii. These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
 - iv. The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed
