I am directed to convey the sanction of the President of India for release of an amount of **Rs. 1,39,71,145/- (Rupees One Crore Thirty Nine Lakh Seventy One Thousand One Hundred and Forty Five Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Gujarat as 27th Installment out of the sanctioned amount of **Rs.116,66,69,000/- (Rupees One Hundred Sixteen Crore Sixty Six Lakh Sixty Nine Thousand Only)** vide Mother sanction order No. **J-11060/20/2024-RE-III SI. No.104** dated 23.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs.27,91,47,181/-** vide mother sanction order of even no. Dated 22.07.2024 (U.O.No.242/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 116,66,69,000/- (NeFMS amount) +Rs. 27,91,47,181/- (Residual amount of previous Mother Sanction) i.e. Rs. 144,58,16,181/-**
