Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 1,76,63,508/- (Rupees One Crore Seventy Six Lakh Sixty Three Thousand Five Hundred and Eight Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Gujarat as 63rd Installment out of the sanctioned amount of **Rs.116,66,69,000/- (Rupees One Hundred Sixteen Crore Sixty Six Lakh Sixty Nine Thousand Only)** vide Mother sanction order No. **J-11060/20/2024-RE-III SI. No.104** dated 23.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs.27,91,47,181/-** vide mother sanction order of even no. Dated 22.07.2024 (U.O.No.242/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 116,66,69,000/- (NeFMS amount) +Rs. 27,91,47,181/- (Residual amount of previous Mother Sanction) i.e. Rs. 144,58,16,181/-**

3. The total amount available for release to the State for wages is **Rs 46,92,05,084/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

7. All other terms and conditions mentioned in sanction order F. No. **J-11060/20/2024-RE-III SI.No.104** dated 23.08.2024 shall remain the same.

8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.

9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.36114318791** in the name of **SEGF-NeFMS-Gujarat**, in the **State Bank of India**, Gandhi Nagar, **IFSC-SBIN0001355**.
