l am directed to convey the sanction of the President of India for release of an amount of Rs. 59,19,333/- (Rupees Fifty Nine Lakh Nineteen Thousand Three Hundred and Thirty Three Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Gujarat as 4<sup>th</sup> Installment out of the sanctioned amount of Rs.350,00,00,500/- (Rupees Three Hundred Fifty Crore and Five Hundred Only) vide Mother sanction order No. J-11060/20/2024-RE-III SI. No.157 dated 17.12.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs. 15,03,30,278/- as refunded amount due to the failed transaction from 1<sup>st</sup> June, 2024 to 31<sup>st</sup> October ,2024 .This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of Rs.24,20,82,890/- vide mother sanction order of even no. Dated 23.08.2024 (U.O.No.374/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds.
