Subject:- **Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 1st Installment of 2nd tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State of Gujarat.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 50,21,553/- (Rupees Fifty Lakh Twenty One Thousand Five Hundred and Fifty Three Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Gujarat as 88th Installment out of the sanctioned amount of **Rs.350,00,00,500/- (Rupees Three Hundred Fifty Crore and Five Hundred Only)** vide Mother sanction order No. J-11060/20/2024-RE-III Sl. No.157 dated 17.12.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs. 15,03,30,278/- as refunded amount due to the failed transaction from 1st June, 2024 to 31st October, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs.24,20,82,890/-** vide mother sanction order of even no. Dated 23.08.2024 (U.O.No.374/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 350,00,00,500/- (NeFMS amount) + Rs. 15,03,30,278/- (re-initiated amount) +Rs. 24,20,82,890/- (Residual amount of previous Mother Sanction) i.e. Rs. 389,24,13,668/-**

3. The total amount available for release to the State for wages is **Rs 184,98,48,556/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

7. All other terms and conditions mentioned in sanction order F. No. J-11060/20/2024-RE-III SI.No.157 dated 17.12.2024 shall remain the same.

8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.

9. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.36114318791** in the name of **SEGF-NeFMS-Gujarat**, in the **State Bank of India**, Gandhi Nagar, **IFSC-SBIN0001355**.
