The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.36114318791 in the name of SEGF-NeFMS-Gujarat, in the State Bank of India, Gandhi Nagar, IFSC-SBIN0001355.
- 10. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
