No.7 dated 06.04.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

7. All other terms and conditions mentioned in sanction order F. No. J-11060/20/2024-RE-III SI.No.7 dated 06.04.2024 shall remain the same.

8. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.



The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No.36114318791 in the name of SEGF-NeFMS-Gujarat, in the State Bank of India, Gandhi Nagar, IFSC-SBIN0001355.

10. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
