I am directed to convey the sanction of the President of India for release of an amount of Rs. 1,93,59,418/- (Rupees One Crore Ninety Three Lakh Fifty Nine Thousand Four Hundred and Eighteen Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Uttarakhand as 11thinstallment out of the sanctioned amount of Rs.63,09,10,243/- (Rupees Sixty Three Crore Nine Lakh Ten Thousand Two Hundred and Forty Three Only) vide Mother sanction order No. J-11060/21/2024-RE-III SI. No.148 dated 28.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 2,73,29,011**/- as refunded amount due to the failed transaction from 1<sup>st</sup> June, 2024 to 31<sup>st</sup> October, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs. 30,62,99,150**/- vide mother sanction order of even no.
