No.148 dated 28.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 2,73,29,011/-** as refunded amount due to the failed transaction from 1st June, 2024 to 31st October, 2024.
