I am directed to convey the sanction of the President of India for release of an amount of Rs. 2,97,15,174/- (Rupees Two Crore Ninety Seven Lakh Fifteen Thousand One Hundred and Seventy Four Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Uttarakhand as 7th installment out of the sanctioned amount of Rs.63,09,10,243/- (Rupees Sixty Three Crore Nine Lakh Ten Thousand Two Hundred and Forty Three Only) vide Mother sanction order No. J-11060/21/2024-RE-III SI. No.148 dated 28.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 2,73,29,011/-** as refunded amount due to the failed transaction from 1st June, 2024 to 31st October, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs. 30,62,99,150/-** vide mother sanction order of even no.
