- 8. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No 35628101247 in the name of SEGF NeFMS Account in the State Bank of India, Branch Sachivalaya, Dehradun, Branch IFSC Code No. SBIN0010164.
- 9.Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
- i) Absolutely no publicity in this regard shall be made in electronic , print, radio and internet or any other media, in any form whatsoever.
- ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- iii) These restrictions on publicity will be applicable on both i.e. Central Government as well as State Government.
- iv) The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
