- 9. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
- i) Absolutely no publicity in this regard shall be made in electronic , print, radio and internet or any other media, in any form whatsoever.
- ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- iii) These restrictions on publicity will be applicable on both i.e. Central Government as well as State Government .
- iv) The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
