I am directed to convey the sanction of the President of India for release of an amount of **Rs. 1,92,08,618/- (Rupees One Crore Ninety Two Lakh Eight Thousand Six Hundred and Eighteen Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Uttarakhand as 22<sup>nd</sup> installment out of the sanctioned amount of **Rs.46,99,57,000/- (Rupees Forty Six Crore Ninety Nine Lakh and Fifty Seven Thousand Only)** vide Mother sanction order No. J-11060/21/2024-RE-III Sl. No.37 dated 22.05.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 17,90,19,156/-** vide mother sanction order of even no. dated 06.04.2024 (U.O.No. 27/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 46,99,57,000/- (NeFMS amount) + Rs. 17,90,19,156/- (Residual amount of previous Mother Sanction) i.e. Rs. 64,89,76,156/-**

6. All other terms and conditions mentioned in sanction order of even number dated 22.05.2024 shall remain the same.

8. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose.
