- 3. - 7. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
- 8. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in **Account No 40104177712** in the name of State NEFMS for Other Account in the State Bank of India, Kohima Branch, Near D.C. Office, Kohima, Nagaland-797001, Branch **IFSCode No. SBIN0000214**.
- 9. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:
- i) Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any form whatsoever.
- ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- iii) These restrictions on publicity will be applicable on both i.e. Central Government as well as State Government .
- iv) The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
