Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs. 3,56,616/- (Rupees Three Lakh Fifty Six Thousand Six Hundred and Sixteen Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Nagaland as 44<sup>th</sup> Installment out of the sanctioned amount of Rs.92,00,58,000/- (Rupees Ninety Two Crore Fifty Eight Thousand Only) vide Mother sanction order No. J-11060/23/2024-RE-III Sl. No.26 dated 09.04.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in sanction order F. No. J-11060/23/2024-RE-III SI.No.26 dated 09.04.2024 shall remain the same.
7. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
8. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No 40104177712 in the name of State NEFMS for Other Account in the State Bank of India, Kohima Branch, Near D.C. Office, Kohima, Nagaland-797001, Branch IFSCCode No. SBIN0000214.
