The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No 40104177712** in the name of State NEFMS for Other Account in the State Bank of India, Kohima Branch, Near D.C. Office, Kohima, Nagaland-797001, Branch **IFSCCode No. SBIN0000214**.
