**Subject:- Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State of Nagaland.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 1,24,29,612/- (Rupees One Crore Twenty Four Lakh Twenty Nine Thousand Six Hundred and Twelve Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account to State of Nagaland as 16<sup>th</sup> Installment out of the sanctioned amount of **Rs.2,67,904/- (Rupees Two Crore Sixty Seven Thousand Nine Hundred and Four Only)** vide Mother sanction order No. J-11060/23/2024-RE-III Sl. No.74 dated 22.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 4,67,303/-** as refunded amount due to the failed transaction from 1<sup>st</sup> April, 2024 to 31<sup>st</sup> May, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs. 72,61,45,418/-** vide mother sanction order of even no. Dated 09.04.2024 (U.O.No.29/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is **Rs. 2,67,904/- (NeFMS amount) + Rs. 4,67,303/- (re-initiated amount)+Rs. 72,61,45,418/- (Residual amount of previous Mother Sanction) i.e. Rs. 72,68,80,625/-**

3. The total amount available for release to the State for wages is **Rs. 61,51,74,945/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in sanction order F. No. J-11060/23/2024-RE-III SI.No.74 dated 22.07.2024 shall remain the same.
7. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
8. The DDO, MGNREGA (207172), New Delhi will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No 40104177712** in the name of State NEFMS for Other Account in the State Bank of India, Kohima Branch, Near D.C. Office, Kohima, Nagaland-797001, Branch IFSCCode No. SBIN0000214.
9. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O. No. 254/Finance/2024-25 dated 12.07.2024.
