No.74 dated 22.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

PAO has reported Rs. 4,67,303/- as refunded amount due to the failed transaction from 1st April, 2024 to 31st May, 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of Rs. 72,61,45,418/- vide mother sanction order of even no. Dated 09.04.2024 (U.O.No.29/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages is Rs. 2,67,904/- (NeFMS amount) + Rs. 4,67,303/- (re-initiated amount)+Rs. 72,61,45,418/-(Residual amount of previous Mother Sanction) i.e. Rs. 72,68,80,625/-
