No.153 dated 04.12.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported Rs. 46,48,015/- as refunded amount due to the failed transaction from 1st June ,2024 to 31st October, 2024. This amount has been included in the current mother sanction for utilizing the fund. The residual amount of Rs. 4,81,316/- vide mother sanction order of even no. Dated 12.07.2024 (U.O.No.254/Finance/2024-25) have been carried forward into the current mother sanction order for the purpose of utilizing the funds.
