

No.125 dated 03/10/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

4. Further instalment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

6. All other terms and conditions mentioned in Mother Sanction Order J- 11060/23/2024-RE-VI, Sl. No.125 dated 03/10/2024 shall remain the same.


7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.


